The Summer Law Program in Madrid

May 24 to July 13, 2008

The Summer Law Program in Madrid* offers seven weeks of enriching, rewarding comparative law education in a distinctive European culture. During the 2008 summer program there will be a break in the week of June 23-27 for all students except those in Comparative Criminal Procedure, who will travel to The Hague, Netherlands, to visit the International Criminal Tribunals.

The Summer Law Program in Madrid allows law students to become immersed in the study of law in an international setting. During the Summer 2007 session there were 30 students in attendance, seven of whom attend law schools besides Saint Louis University School of Law. Students can earn up to six credit hours of comparative law with foreign and American professors who have extensive experience in the fields of foreign and American criminal law, civil law and global human rights. The program offers students the opportunity to advance their legal education while absorbing the sights, sounds and culture unique to Madrid and Spain.

While in Madrid, students can experience enticing nightlife, regional and ethnic cuisine and world-renowned museums while enjoying an absorbing and fulfilling academic experience.

A wealth of Spanish heritage is located near Saint Louis University's Madrid campus. Cities such as Toledo, Segovia, Avila and Salamanca are all less than three hours away. Works of art by Goya, Velazquez, El Greco, Picasso and others can be found in three of the world's greatest museums — the Prado, Thyssen-Bornemisza and Reina Sofia.

Walking the streets of Madrid presents many opportunities for shopping. Neighborhood shops offer specialty items, including Spain's fine leather goods. Department stores, such as El Corte Ingles, offer a variety of items, including gourmet foods. For shopping with an eclectic flavor, students can visit El Rastro, Madrid's famous flea market open on Sundays.

The Summer Law Program is ideal for those wishing to study law in one of the most exciting, historical and culturally rich settings in Europe.

The School of Law has a long history of offering comparative law courses taught by foreign scholars in its J.D. curriculum. The Summer Law Program in Madrid builds on this strong comparative and international law focus by offering six comparative law courses. It is held on Saint Louis University's Madrid campus, located in the northwest area of Madrid, near many other universities.

European Human Rights and Introduction to Civil Law Systems are taught by Spanish legal scholars Professors Ignacio Borrajo Iniesta, Lorena Bachmaier Winter and Javier Martínez Torró. Spanish Criminal Procedure in Comparative Perspective will be taught by Saint Louis University School of Law Professor Stephen C. Thaman. He will also teach



Comparative Criminal Procedure: Emphasis on Spain and the International Criminal Tribunals. Professor Thaman is the Director of the Summer Law Program in Madrid and the Co-Director of the Center for International and Comparative Law. International Environmental Law will be taught by Saint Louis University School of Law Professor Douglas R. Williams. Comparative Health Law will be taught by Saint Louis University School of Law Professor Jesse Goldner.

Students may take a maximum of six (6) hours while enrolled in the Madrid program. Classroom instruction is in English, and the program includes site visits to various Spanish courts. Students enrolled in Comparative Criminal Procedure: Emphasis on Spain and International Criminal Tribunals will travel to the International Criminal Tribunal for the Former Yugoslavia and the International Criminal Court in The Hague, Netherlands where they will observe court hearings and visit with judges, prosecutors, lawyers and other officials of the two courts.

** Those taking Comparative Criminal Procedure will also spend a week in The Hague, Netherlands at the International Criminal Tribunals.*

PLEASE NOTE

It is unlikely that participation in foreign summer programs would accelerate graduation. Students interested in acceleration should be referred to their home schools to review this issue in light of American Bar Association Standard 304, Interpretation 4.

course descriptions

Comparative Criminal Procedure: Emphasis on Spain and the International Criminal Tribunals (2 credit hours)

Students in this class will participate in all of the sessions of "Spanish Criminal Procedure in Comparative Perspective" for one credit, but will have an extra hour of class each week dedicated to the law of the International Criminal Tribunals for the Former Yugoslavia (ICTY) and Rwanda (ICTR) and the International Criminal Court (ICC). During the one-week break in classes (June 23-27, 2008), the class will go to The Hague, Netherlands, to visit the ICTY and the ICC, watch trials and other proceedings, and hear talks by judges, prosecutors, lawyers and other officials of the two courts. Travel and accommodation costs to The Hague are the students' responsibility. The class will also have a take-home exam which will include a comparison of the procedural and evidentiary aspects of international criminal law as conducted in the international tribunals with the general principles that are a part of the one credit class. Students may only take one of the two criminal procedure classes.

Comparative Health Law (2 credit hours)

This course will explore a variety of selected topics in comparative health law. The course is located within the tradition of the discipline of micro-comparative law. It will focus on understanding how a wide variety of disparate legal systems deal with issues in health care law and is designed to demonstrate that there are very different solutions to health law dilemmas than those commonly considered in the American context. It begins with a comprehensive examination of the right to health and its implementation, including a section generally describing how health care systems are organized and function. The remainder will review selected topics from within three general areas: the rights of patients in relationship with health care professionals and institutions (e.g., right to freedom from negligence); patients' rights to self-determination (e.g., the right to die); and patient rights vs. societal rights (e.g., the rights of research subjects). The course will not presuppose any knowledge of comparative law or health law. Enrollment in this course will not preclude enrollment in another currently offered course or seminar. The course will satisfy the comparative law requirement for the International and Comparative Law Certificate and apply toward the Certificate in Health Law.

European Human Rights Law (H) (2 credit hours)

This course provides an overview of the protection of civil and political rights in Europe, both those protected by the European Convention of Human Rights and European Union law. It will focus on recent developments, like the new treaties of the European Union (Lisbon, December 2007) and the situation of new democracies created after the fall of the Berlin wall, as well as the case law of the European Court of Human Rights and the Court of Justice of the European Union. Some selected areas shall be emphasized, such as the rights to life and physical integrity, international migrations, or linguistic, religious and cultural pluralism.

International Environmental Law (2 credit hours)

This course addresses some of the legal, scientific, political, economic and institutional issues associated with global environmental management and protection. These issues will be addressed by looking at current environmental challenges, including global climate change, depletion of the stratospheric ozone layer, loss of biodiversity and transboundary pollution. The course also considers the evolving understanding of terms like sustainable development, common but differentiated responsibilities among states, the precautionary principle, and common heritage of mankind. Grades will be based on a final examination. The course satisfies the comparative law requirement for the Certificate in International and Comparative Law.

Introduction to the Civil Law Systems (H) (2 credit hours)

This course provides an introduction to the Civil Law tradition as it has developed in today's continental European legal systems. Students will be introduced to the historical sources of the Civil Law tradition, such as Roman and Canon Law and the Code Napoleon. They will gain an understanding of how and why the tradition of codified law developed on the European continent in contrast to the Common Law in England. The basic structure, principles and jurisprudence of the Civil Law systems will be explored and compared to those of the Common Law, leading the student to appreciate the strengths and weaknesses of both traditions. Students will also study the areas in which trends toward convergence or divergence of Civil Law and Common Law can be identified, and the questions they raise in the context of the European unification process. Particular attention will be given to the development of the Civil Law tradition in Spain and to Spanish procedure and jurisdiction, as well as to the EU legal institutions. The course will not presuppose any knowledge of the Civil Law tradition or comparative law.

Spanish Criminal Procedure in Comparative Perspective (H) (1 credit hour)

Students in this class will learn the basics of comparative criminal procedure in two days of class per week using the Second Edition of Professor Thaman's book *Comparative Criminal Procedure: A Casebook Approach*, which will be published in early 2008. On Tuesday mornings, the class will visit the municipal investigative courts (juzgados) and watch proceedings in the new Domestic Violence Courts, the provincial court to see jury and nonjury trials; the National Court, to see terrorism and organized crime trials; the Supreme Court; and the Constitutional Court. The students will compare the real-life functioning of the courts with the theoretical principles and jurisprudence of European criminal procedure and discuss their conclusions in a take-home exam. Areas of emphasis will be the investigation, exclusionary rules, plea-bargaining, jury trials, and the tension between adversarial and inquisitorial procedure. Students may only take one of the two criminal procedure classes.

Professor Lorena Bachmaier Winter

Complutense University of Madrid, J.D.; Complutense University, M.A. in Political Science; Complutense University, J.S.D.

Professor Bachmaier Winter has been a Professor at the Faculty of Law at Complutense University since 1996, where she has taught criminal procedure and civil procedure. She has written extensively on the subject of procedure. She has lectured in universities and governmental agencies in Europe and Latin America. She is a member of the Spanish Royal Academy of Jurisprudence and Legislation and of the Ibero-American Association of Procedural Law. She has been a fellow of the Alexander von Humboldt Foundation, and a visiting scholar in the Max-Planck-Institut for Criminal Law and Procedure (Freiburg i. Br., Germany) and at the University of California – Berkeley and Harvard University. Her comparative legal studies are focused on human rights and procedure, international judicial cooperation, comparative law and the EU process of legal harmonization. She has consulted for the Ministry of Justice of Spain.



Professor Ignacio Borrajo Iniesta

Complutense University of Madrid, J.D.; Complutense University of Madrid, Doctor in Law; Harvard Law School, LL.M.

Professor Borrajo Iniesta was Associate Professor of Law at the Complutense University in Madrid from 1984 to 1989 and was appointed a full Professor of Law at the University of Navarra, where he taught from 1993 to 1995. He has also lectured at the Sorbonne in Paris, the European University in Florence, Italy, the Academy of European Public Law in Spetses, Greece and at the College of William and Mary, both in Virginia and at their Summer Program in Madrid. He is currently Senior Staff Attorney at the Constitutional Court of Spain in Madrid, where he also teaches at the University Institute Ortega y Gasset. He has collaborated as an expert with the Council of Europe in the fields of human rights and the rule of law, and has published widely in the areas of constitutional and administrative law, European Community law, due process and other public law subjects.



Professor Jesse Goldner

*John D. Valentine Professor of Law
Columbia University, A.B. in Political Science; Columbia University, M.A. in Psychology; Harvard Law School, J.D.*

Jesse Goldner is the John D. Valentine Professor of Law at Saint Louis University School of Law. He holds secondary faculty appointments at the University's School of Medicine as Professor of Law in Psychiatry and Professor of Pediatrics, as well as in the University's School of Public Health and Center for Health Care Ethics. He has served as a Visiting Professor at the University of Warsaw in Poland, the University of Warwick in England, New York Law School and the University of San Diego. Professor Goldner has written extensively in the areas of Health Law and Bioethics. Together with three others, in 2005 he authored *The Ethics and Regulation of Research with Human Subjects*, published by LexisNexis press, and served as the co-editor-in-chief of the *Journal of Health Law*, published by the American Health Lawyers Association from 1996-2007. He is a member of the Council on Accreditation of the Association for the Accreditation of Human Research Protection Programs and chaired the Council in 2005. He received the 2004 Jay Healey Distinguished Health Law Teacher of the Year Award from the American Society of Law, Medicine & Ethics.



Professor Javier Martínez-Torrón

University of Granada, J.D.; University of Navarra, J.C.L.; University of Navarra, J.S.D; University of Navarra, J.C.D.; Professor of Law, Complutense University of Madrid

Professor Martínez-Torrón has been Professor of Law (Catedrático) at Complutense University of Madrid since 2000. Formerly a Professor at the University of Granada (1993-2000), his teaching areas are Comparative Law, Law and Religion, Marriage Law and Canon Law. In these areas he has published extensively in 18 countries and 8 languages. He has taught or lectured in a number of universities and international conferences in Europe, America and Asia. He has developed part of his research at Cambridge University, University of Chicago, Columbia University, Harvard University, among others. He is Vice-President of the Canon Law and Law-and-Religion section of the Spanish Royal Academy of Jurisprudence and Legislation. He was co-founder of the Spanish Association of Comparative Law and a member of its Board of Directors. He is also a member of the International Academy of Comparative Law, the OSCE/ODIHR Advisory Council on Freedom of Religion or Belief, the Advisory Commission on Religious Freedom in the Spanish Ministry of Justice, and of the Bioethics Committee of the Autonomous Region of Madrid.



Professor Stephen C. Thaman

Director, Summer Law Program and Co-Director, Center for International and Comparative Law; University of California – Berkeley, B.A., M.A., J.D.; University of Freiburg, Germany, Dr. iur.

Professor Thaman was an Assistant Public Defender in California for 11 years from 1976 to 1987, a Fulbright scholar at the Free University of Berlin from 1987 to 1988 and was an attorney-trainee at the European Commission of Human Rights in Strasbourg, France in 1988. From 1990 to 1991, he was a senior fellow at the International Institute for Higher Studies in Criminal Sciences in Siracusa, Italy. From 1992 to 1995 he worked in Moscow, Russia, as an IREX fellow at the Institute of State and Law of the Russian Academy of Sciences and later as liaison for the ABA Central and Eastern European Law Initiative (CEEI). He has written authoritative studies of new jury and mixed court systems in Russia, Spain, Venezuela, Japan and Kazakhstan and has written about other aspects of criminal justice reform in Russia. He regularly publishes articles related to U.S. and comparative criminal law and procedure in Germany, Spain and other western European countries, as well as in Russia and other ex-Soviet Republics and has lectured on these subjects in 25 countries on five continents. He is the author of *Comparative Criminal Procedure: A Casebook Approach* (2002) and also translated the German Penal Code for the American Series of Foreign Penal Codes. He has consulted with the governments of Russia, Latvia, Georgia and Indonesia on criminal procedure reform and is an expert on criminal procedure with the Organization for Security and Co-operation in Europe.



Professor Douglas R. Williams

Augustana College, B.A.; Duke University, M.A.; Duke Law School, J.D., Order of Coif

Professor Doug Williams is a professor of law at Saint Louis University School of Law. A 1987 graduate of Duke University School of Law, he clerked for Douglas H. Ginsburg of the United States Court of Appeals for the District of Columbia Circuit. From 1988 to 1991, he was associated with the law firm of Covington & Burling in Washington, D.C., practicing in the areas of environmental law, administrative law and appellate practice. In 1991 he joined the law faculty at Saint Louis University School of Law, and he now teaches and writes in the areas of environmental law and natural resources, administrative law and constitutional law.

Housing

The Madrid Campus contracts with nearby apartment locations to house law students during the Summer Law Program in Madrid.

The campus is safe, clean and situated in the pleasant "university" area of Madrid. There is an entrance to the Madrid subway nearby. Administrative offices are located in the main building of the Madrid campus and are staffed between the hours of 8:30 a.m. and 5 p.m., Monday through Friday.

Note: When making payment, please take into consideration the current conversion rate of United States Dollars to the Euro. You are responsible for paying your housing in the equivalent of Euros listed for the option you choose.

Housing and Meal Costs

- Double room with shared bath: With lunch daily and continental breakfast on class days — €2000
- Double room with private bath: With lunch daily and continental breakfast on class days — €2200
- Single room with shared bath: With lunch daily and continental breakfast on class days — €2400
- Single room with private bath: With lunch daily and continental breakfast on class days — €3300
- Host family: With breakfast and dinner with host family — €1840

* Lunch is the main meal of the day in Spain.

Program Cancellation

Saint Louis University School of Law reserves the right to alter or cancel this program. Cancellation would occur if there is insufficient enrollment or unanticipated international events which have the potential to affect participants' safety and/or inhibit program administration. If cancellation becomes necessary and occurs after a deposit has been paid, the Program Director will make his best effort to make arrangements for each student enrolled to attend a similar program, if the student desires. If the program is canceled, all money advances by the student shall be refunded within 20 days of cancellation.

If, prior to the commencement of the program, a U.S. State Department Travel Warning is issued for Spain, all registrants will be notified promptly of the warning and be given the opportunity to withdraw from the program. Students who withdraw shall receive a full refund of all monies advanced within 20 days after withdrawal. In the event the program is canceled, students shall receive a full refund of all monies advanced within 20 days after the cancellation.

If, during the course of the program, a U.S. State Department Travel Warning is issued for Spain, students will be promptly notified and given the opportunity to withdraw from the program. Students who withdraw will be refunded paid tuition and fees, except for room and board payments utilized before the date of withdrawal. If the program is terminated, students shall be refunded fees paid except for room and board payments utilized prior to the date the Travel Warning is issued.

Deadlines

- Applicants should apply as soon as possible since the maximum enrollment is 50 students.
- Admission decisions are made as applications are received until the program is full.
- Application deadline (including application fee) is April 1, 2008.
- Total tuition and fees deadline (including room and board) is April 30, 2008.

Accessibility

Conduct

Saint Louis University School of Law expects that summer law students uphold the highest possible standard of personal and professional behavior. Regular and punctual class attendance is required. In addition, students must abide by campus and housing policies and procedures while residing on campus or with a host family. Failure to do this will result in disciplinary consequences up to and including suspension from the program. Students are subject to the provisions outlined in the School of Law Student Handbook and the Student Honor Code. Class Attendance Policy

Regular and punctual class attendance is required during the Summer Law Program in Madrid. If a student misses more than three (3) hours of class he/she will be dropped from the class.

key information

Eligibility

To qualify to study law in Madrid students must have completed their first year of law school and must be in good standing with their institution. However, students who have completed fewer than 30 hours of coursework should contact the Assistant Director of the Center for International and Comparative Law prior to completing the application. For additional information pertaining to the part-time evening student requirement, please see the Assistant Dean of Students.

Currently, admission to the Summer Law Program in Madrid is limited to students from U.S. law schools.

Please Note: Acceptance of any credit or grade for any course taken in the program is subject to determination by the student's home school.

Tuition and Fees

- Seven-week program — \$4,000 Estimated
- Travel costs and personal expenses not included.
- The \$100 application fee will be credited toward tuition. There will be visits to legal institutions in Madrid such as the Spanish Constitutional Court and Ministry of Justice, Spanish Supreme Court, National Court of Spain and the Madrid Provincial Court. Students enrolled in Comparative Criminal Procedure will travel to the International Criminal Tribunal for the Former Yugoslavia and the International Criminal Court in The Hague, Netherlands. They will also visit with judges, prosecutors, lawyers and other officials of the two courts.

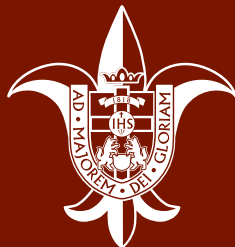
